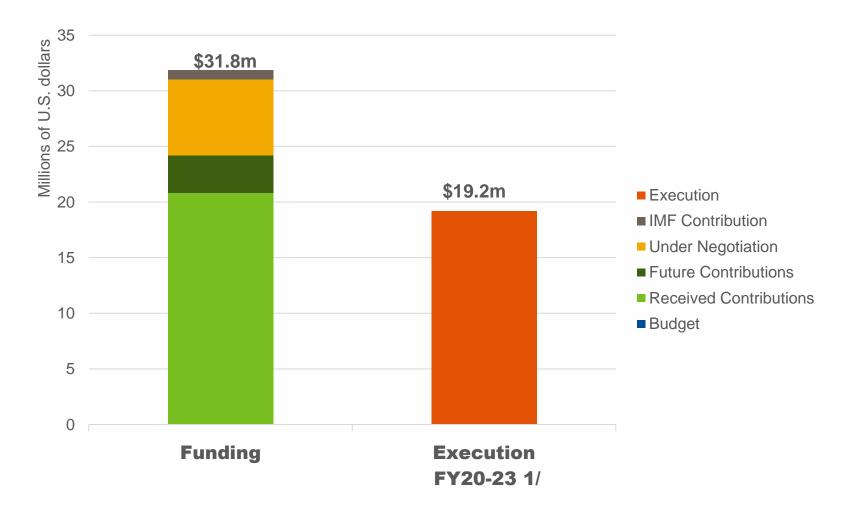


#### ATI - Phase II (FY20-24) Financial Overview

(in millions of U.S. dollars; as of April 30, 2023)







## **ATI Mid-Term Evaluation**

?

**The Piloting Initiative:** groups three evaluations (ATI, AFW2 and CAPTAC-DR), in one joint in-depth evaluation of CD performance for a few select thematic areas.

**Scope**: in-dept evaluation focusing on 2 workstreams across the 3 RCDC - Tax Administration and Customs Administration.



**Expected benefits:** 1) Deeper analysis; 2) cross-vehicle and cross-regional findings' fertilization to improve vehicle design and operations (e.g., delivery practices, governance).

Timeline: Sept 2022 – December 2023



- Status:
- The evaluators have completed the field case studies, survey, interviews with key stakeholders (donor partners, beneficiaries, IMF staff) and documentation review.
- The evaluation report will be ready for review in late October or November 2023.
- In-depth discussion with the ATI SC is scheduled during the SC Mid-Year Meeting in Dec 2023


